 - c. Best of luck to Kingswood (Lucas and Cam) and Mascoma (Tanner and Cole) at the HS Nationals
 - d. Congratulations to Tim Dube and Peter Owen at the Regional Championship. Tim won the entire event. He is from the Last Cast club! Regional team did a great job coming in 2nd place overall. 4500 dollars for payout. 25% of that goes towards the state. The board decides what happens to the 25% and the remaining goes to the anglers. Anglers also get any prize money and contingency money they won individually.
 - e. Club vs Club attendance. Bring cash.
 - f. Humminbird Team of the Year standings updated. Published on Facebook and Website. Top 3 teams move on to Team Championship on Hartwell in the first week of December. We do go down the list if teams are unable to make it. Opportunity to go to the Classic. Four-day event – top teams fish individually at the end of the tournament. Winners go on to Classic.
